

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PRIZE DRAWING. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

1. ELIGIBILITY. The "Ramblin Reck Club For a Day Enter to Win" (the "Prize Drawing") is sponsored by Ford ("Sponsor"), Georgia Tech Athletic Association ("University") and Legends (Administrator). The Prize Drawing is open only to entrants who, as of the entry date, are legal residents of the fifty (50) United States and the District of Columbia, and are at least eighteen (18) years old. The Prize Drawing is void in all other jurisdictions and where prohibited or restricted by law. Employees, agents, representatives, officers and directors of Sponsor, and its subsidiaries, affiliates, advertising and promotional agencies, and the immediate families (defined as spouses and biological, adoptive or step-parents, legal guardians, children, siblings, or grandparents, their respective spouses and any dependent under applicable income tax law) or members of the same household (those who share the same residence, whether related or not) of each are not eligible to enter. The Prize Drawing, and any website pages and advertisements relating thereto, is intended for viewing only within the jurisdictions where the Prize Drawing is offered and entrants must be present in the United States or the District of Columbia at the time they enter. **2. ENTRY PERIOD.** The Prize Drawing entry period begins at 9:00 a.m. Eastern Time on November 15, 2021 and ends at the earlier of 11:59 p.m. Eastern Time on November 21, 2021 or when all instant win prizes have been won (the "Entry Period"). Sponsor's server clock is the official timekeeper in this Prize Drawing.

3. HOW TO ENTER

a. There are two (2) methods of entry in the Prize Drawing (by mail and via online form) as described below.

i. **MAIL-IN METHOD OF ENTRY (NO PURCHASE NECESSARY):** During the Entry Period, hand print or type your full name, complete home address, day and evening phone numbers, email address (if any), and age (including year of birth) on a 3" x 5" piece of paper and send it by United States mail in a sealed envelope no larger than 9 1/2" x 4 1/4" (a #10 envelope) with correct postage to

All mail-in entries must be received by Administrator during the Entry Period. No facsimiles, photocopied or mechanically reproduced entries allowed. Use of any automated system to submit entries is prohibited and will result in disqualification.

ii. **ONLINE ENTRY:** During the Entry Period, complete the online registration form located at ramblinwreck.com/Ford. A link to the form can be requested by calling 404-894-5875 during regular business hours (Monday – Friday, 9:00 a.m. to 5:00 p.m. Eastern Time).

b. **FOR ALL ENTRIES:** All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of online entry submission or mail in entry submission will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, proof of age and other claims of/information provided by a potential prize winner. Duplicate entries will be voided. **LIMIT:** One prize per participant, household and/or family.

4. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in the Prize Drawing, each entrant irrevocably, fully and unconditionally agrees to be bound by and accepts these Official Rules, and any other documents, instruments, releases and agreements required under these Official Rules, and the decisions of Sponsor and Administrator (including, without limitation, decisions regarding eligibility of entries, the selection of winners, and the awarding of the prizes), which are final and binding in all respects. By participating, each entrant waives any right to claim ambiguity in these Official Rules and or any other Prize Drawing-related advertising or materials.

5. WINNING; NOTIFICATION; ODDS.

- a. One (1) random winner will be generated during the Entry Period.
- b. Each potential winner must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements stated herein. Each potential winner (and if applicable, the selected entrant's parent or legal guardian) will be required to execute and return to Sponsor/Administrator an Affidavit of Eligibility, a Liability Release, and a Publicity Release (except where prohibited by law) (an "Affidavit/Release") in the form(s) provided by Sponsor/Administrator in order to claim his/her prize. The Affidavit/Release must be returned to Sponsor/Administrator by the date and/or time indicated within the Affidavit/Release or such potential winner may be disqualified.

- One (1) football autographed by the Head Football Coach

- b. All prizes in the Prize Drawing are nontransferable, nonassignable, nonnegotiable, and not redeemable for cash or credit. Age restrictions are applicable to some prizes. All prizes must be accepted as awarded. Prizes are awarded "AS IS" with no warranty, representation or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. No cash or other substitution may be made, except by Sponsor, who reserves the right (but has no obligation) to substitute a prize (or a component thereof) with another prize (or component thereof, including cash) of equal or greater value if a prize is not available for any reason as determined by Sponsor in its sole discretion. Prize winners and guest(s) must comply with all

rules and regulations. Each winner is solely and fully responsible for any and all costs, fees, taxes, assessments and expenses associated with prize award, redemption, receipt and use, including, without limitation, all federal, state and local taxes on the prize. Entrants waive the right to assert as a cost of winning a prize any and all costs of verification and redemption to redeem or use any prize in the Prize Drawing.

7. PUBLICITY. In such event, Sponsor reserves the right in its sole discretion (but do not have any obligation) to award the applicable prize to a potential winner from among eligible, non-suspect entries received up to the time of the suspected impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Prize Drawing or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of the Prize Drawing may be a violation of criminal and civil laws, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. By entering, each entrant forever and irrevocably releases, discharges and holds harmless Sponsor, University, and Administrator, and their respective parents, subsidiaries, affiliates and agents (including advertising and promotion agencies), and all of the respective employees, officers, directors, members individually, and agents of all of the foregoing from and against all claims, damages, causes of action of whatever kind or nature or liabilities arising in whole or in part, directly or indirectly, known or unknown, foreseen and unforeseen, resulting in any way whatsoever from entrant's participation and/or entry in the Prize Drawing and/or entrant's award, receipt or use of any prize awarded in the Prize Drawing.

10. LIMITATIONS OF LIABILITY. Sponsor is not responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website, wireless service, or other service; (d) unauthorized intervention in any part of the entry process or the Prize Drawing; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Prize Drawing or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to entrant's computer, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Prize Drawing, or from viewing, playing or downloading any material from Sponsor's website(s), regardless of whether the material was
