



FOOTBALL FAN DAY WAIVER AND RELEASE FORM

In consideration for being permitted to attend Georgia Tech Football’s Fan Day Event (the “**Event**”), which will include without limitation, me voluntarily attending the Event itself and other activities relating to or arising from the Event and certain voluntary engagements in/around Bobby Dodd Stadium on Georgia Tech’s campus (the “**Football Stadium**”), including, but not limited to, football combine drills and other physical activities, I irrevocably accept and agree to be bound by, these terms and conditions and voluntarily enter into this Waiver and Release Form (this “**Release**”) individually and on behalf of all persons attending with me, including my minor/child, hereby (all references to “me” or “I” hereunder will be interpreted to mean me and all persons attending with me, including my minor/child).

I HAVE VOLUNTARILY AGREED TO ATTEND THE EVENT. I UNDERSTAND AND EXPRESSLY ACKNOWLEDGE THAT ATTENDANCE IS POTENTIALLY DANGEROUS DUE TO, AMONG OTHER THINGS, PHYSICAL ACTIVITIES, RISK OF SPREADING OR ACQUIRING COVID-19 OR SIMILAR INFECTIOUS DISEASE AND OTHER UNANTICIPATED AND UNEXPECTED DANGERS MAY ARISE FROM MY ATTENDANCE AT THE EVENT. I HEREBY ASSUME ALL RISK OF LOSS, DAMAGE AND/OR INJURY (INCLUDING DEATH) TO MY PERSON AND/OR PROPERTY ASSOCIATED WITH MY ATTENDANCE AT THE EVENT, INCLUDING WHETHER CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF THE GEORGIA TECH ATHLETIC ASSOCIATION, THE GEORGIA INSTITUTE OF TECHNOLOGY, THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA, AND EACH OF ITS PARENT, SUBSIDIARY, AND AFFILIATE COMPANIES AND EACH OF ITS OFFICERS, DIRECTORS, SHAREHOLDERS, EMPLOYEES, INDEPENDENT CONTRACTORS, AGENTS, OR REPRESENTATIVES (COLLECTIVELY, THE “**RELEASED PARTIES**”).

I agree to adhere to all Event conditions and hereby release any claim now or hereafter existing against the Released Parties at the Football Stadium. I further agree to defend, indemnify, and hold harmless the Released Parties from and against all claims (including by third parties), damages, causes of action or liabilities arising in whole or in part, directly or indirectly, known or unknown, foreseen and unforeseen, resulting in any way whatsoever from all activities arising out of the Event, whether caused by the negligence of the Released Parties, or while participating in such activity or while in or upon the premises where the activity is being conducted. I assume all risk of property damage, as well as personal injury to myself. Also, Georgia Tech staff reserves the right to remove any attendees at the staff’s sole discretion.

Lastly, I grant the Georgia Tech Athletic Association (hereinafter referred to as the “**Association**”) all rights to use my photograph(s) from the Event in perpetuity for any and all marketing it engages in, and any and all publications, videos, websites or other printed or electronic materials produced by the Association or its agents for the Association’s use and benefit. I understand that, by granting the Association these rights, I waive any claim or action of any nature arising because of, or in connection with, the photographic session and/or use of my photographic image(s).
