## **Official Rules**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS PRIZE DRAWING. A PURCHASE AND PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY. The "Mother's Day Giveaway" (the "Prize Drawing") is sponsored by "D. Geller & Son Jewelry", Georgia Tech Athletic Association ("University") and Legends ("Administrator"). The Prize Drawing is open only to entrants who, as of the entry date, are legal residents of the fifty (50) United States and the District of Columbia, and are at least eighteen (18) years old.   - i. These actions must be completed on at least one (1) of the following social media platforms: Facebook, Instagram, and/or X (previously known as twitter).

Proof of online entry submission will not be deemed to be proof of receipt of entry by Sponsor.
