BARK IN THE PARK WAIVER AND RELEASE FORM

I agree to adhere to all event conditions and hereby represent that my dog is **non-aggressive, well-behaved in crowds of dogs and people, not in heat, in good health (free of fleas or ticks or a disease that would endanger people or other dogs) and current on all vaccinations (including, but not limited to, rabies).** I agree to keep my dog within the designated dog approved areas. I hereby release any claim now or hereafter existing against the Georgia Tech Athletic Association and all sponsors of “Bark in the Park” at Mac Nease Baseball Park at Russ Chandler Stadium (the “Event”) which I may have resulting from mine or my dog’s participation in this Event.

I further agree to defend, indemnify, and hold harmless the Georgia Tech Athletic Association, the Board of Regents of the University System of Georgia on behalf of the Georgia Institute of Technology, and their respective parents, subsidiaries, affiliates and agents (including advertising and promotion agencies), and all of the respective employees, officers, directors, members individually, and agents of all of the foregoing (the “Releasees”) from and against all claims (including by third parties), damages, causes of action or liabilities arising in whole or in part, directly or indirectly, known or unknown, foreseen and unforeseen, resulting in any way whatsoever from the actions of my dog in connection therewith, whether caused by the negligence of the Releasees, or while participating in such activity or while in or upon the premises where the activity is being conducted. I assume all risk of property damage, as well as personal injury to myself and my dog that may arise from our participation in this event, or that may be incurred during the baseball game. I am aware that personnel within Mac Nease Baseball Park at Russ Chandler Stadium reserves the right to refuse entry of dogs that do not meet all qualifications. Also, Georgia Tech officials reserve the right to remove dogs and their respective owners from the stadium during the baseball game at their sole discretion.

Lastly, I grant the Georgia Tech Athletic Association (hereinafter referred to as the “Association”) all rights to use my photograph(s) from this Event in perpetuity for any and all marketing it engages in, and any and all publications, videos, websites or other printed or electronic materials produced by the Association or its agents for the Association’s use and benefit. I understand that, by granting the Association these rights, I waive any claim or action of any nature arising because of, or in connection with, the photographic session and/or use of my photographic image(s).

MANDATORY QUALIFICATIONS FOR ENTRY

To create the best possible environment for dogs, owners, players and fans:

- All owners must sign a waiver
- Only two (2) dogs per owner may enter the stadium.
- Owners and dogs are welcome to sit in Section 12 and the nearby concrete area within Mac Nease Baseball Park at Russ Chandler Stadium.
 - Reserved and bleacher seats are off limits, notwithstanding Section 12 bleacher seats.
 - Permitted owners will be supplied with a wristband to leave and re-enter the stadium.
- **Dogs must be non-aggressive, good in crowds of dogs and people, not in heat, in good health (free of fleas or ticks or a disease that would endanger people or other dogs) and current on all vaccinations (including, but not limited to, rabies).**
- Dogs must be on a leash at all times.
- Children with dogs must be accompanied by an adult 18 years of age or older at all times.
- Owners must promptly bag and dispose of any waste created by their dog.
